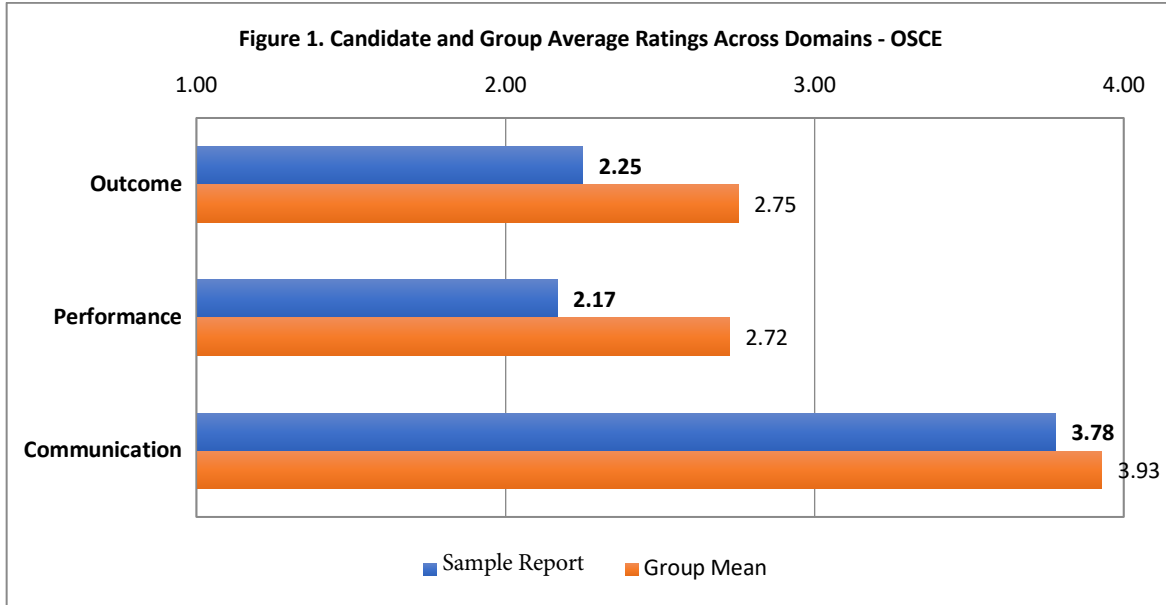
*Outcome* ratings reflect the degree to which station objectives are met and range from the lowest possible score of 1 (Unsolved) to the highest possible score of 4 (Problem solved). *Performance* ratings reflect the overall depth, completeness, and quality of candidate performance in each station and range from the lowest possible score of 1 (Unacceptable) to the highest possible score of 4 (Acceptable). *Communication* ratings reflect the degree to which communication competencies are met and range from the lowest possible score of 1 (Unacceptable) to the highest possible score of 4 (acceptable).

Each practice area is a broad grouping of competencies determined by the profession to be necessary for entering optometry practice in Canada. Note that the practice areas of Collaboration Practice, Scholarship, and Practice Management are not assessed on the OSCE. When reviewing the charts please remember that information provided in Figures 1 and 2 has been calculated solely for the purposes of feedback. The information, as presented, cannot be directly translated to Your Total Score.

**Feedback Charts**

**Figure 1** presents your average scores across the rating domains (areas) of “Outcome,” “Performance,” and “Communication”. The elements of Outcome and Performance are assessed in all 12 stations while Communication is assessed only in the 9 stations with a standardized patient.



**Figure 2** presents your scores across the 4 practice areas assessed in the OSCE. The chart indicates as a percentage the points that you achieved compared to total possible points available for each practice area. Please note that the number of total possible points varies with some practice areas having more points available than others. For example, the practice area of Assessment has more total possible points available than the practice area of Patient Centered Care.
